Free Challenge 25 Posters

It is a criminal offence to buy alcohol on behalf of a child.

You could face a £5000 fine.

Under the provisions of the Licensing Act 2003, it is an offence for persons under 18 years to purchase or attempt to purchase alcohol. It is also an offence for anyone to purchase or attempt to purchase alcohol for someone under 18.
